Roles & Responsibilities:

- 1. To ensure that every student shall submit an undertaking duly signed, one signed by student and the other signed by the parent that the student will not involve even partially in any incident of ragging.
- 2. Every student, at the time of admission/re-registration will be supplied Anti- Ragging Regulations of the University.
- 3. Ragging and its serious consequences shall be pasted on conspicuous places in the University.
- 4. Take necessary steps to sensitize students, parents, authorities about the gravity of ragging. This may be done with the help of audio visuals, electronics and print mediums.
- 5. Provide instructions on whom to contact in case of incidence or attempt at ragging. This would include contact mobile numbers of Anti- ragging committees, Anti- Ragging Squad, Anti-Ragging helpline and relevant state, District, and Police Authorities.
- 6. Keep constant Vigil and stop the incidences of ragging, if any, happening /reported in the places of student aggregation including classrooms, canteens, buses, grounds, hostels etc.

- Every single incident of ragging, a FIR shall be lodged without exception by the University authorities with the local police. In addition one or any combination of the following punishments can be awarded.
 - Cancellation of admission /suspension /from attending classes/ expulsion from the hostel.
 - With holding/withdrawing Scholarship /fellowship and other benefits.
 - Debarring from appearing in any test / examination or other evaluation process/ withholding results.
 - Debarring from representing the institution in any Regional, national, International meet, tournament, Youth Festival, etc.
 - Rustication from the institution / University for period ranging from 1 to 4 semesters
 - Expulsion for the institution and consequent or debarring from admission to any other institution.
 - Collective punishment : When the person committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.

Annual Report

The Chairperson of the committee will prepare an annual report at the end of each academic year, giving a full account of the activities of the committee during the year gone by. A copy of the report may be sent to Registrar, AISECT University, Hazaribag.
